Introductory Remarks

Ms. Goldring added that a few new students enrolled that week which would improve the ADA. She continued that while all three schools are at a loss, the primary academy is struggling the most and decreasing absences would improve the average daily attendance. Discussion ensued and the financials were approved to report to the Board of Directors.

LAUSD 2nd Interim Report

Ms Dietz made a presentation regarding the LAUSD 2^{nd} Interim report. Discussion ensued and the 2^{nd} interim report was approved to report to the Board of Directors.
